Friendly Reminder



In accordance with <u>Massachusetts Smoke-Free Workplace Law</u>, smoking is prohibited at all times *anywhere* inside Cummings Properties' garages or buildings. By state law, all those wishing to smoke must do so outdoors and *at least 30 feet away* from any building entrance. This law also applies to the use of **e-cigarettes**, which are considered "nicotine delivery products" and are comparable to tobacco cigarettes. In addition, client firms with after-

hours staff should remind employees that building entrance doors should *not* be propped open at any time, including when employees leave the building briefly to smoke.
