Update on Face Covering Requirements: We are pleased that, per Governor Baker's recent announcement, all industries in the Commonwealth are now permitted to operate at 100 percent capacity. We look forward to welcoming even more clients back to our business campuses and resuming business as usual.

A number of clients have inquired about face covering requirements in our buildings. As we have throughout the pandemic, Cummings Properties will continue to follow guidance issued by local Departments of Public Health and the Centers for Disease Control and Prevention (CDC).



As of May 29, the Commonwealth's mask order has been rescinded. The Department of Public Health has issued a new mask advisory consistent with the CDC's updated guidance that advises all unvaccinated residents to continue to wear masks in indoor settings and when they can't socially distance.

Signage will be posted within building common areas indicating this guidance.

Please note that according to the Commonwealth's guidance, masks are still mandatory in some locations, including healthcare facilities and in other settings hosting vulnerable populations, such as congregate care settings.

Fun facts about the historic Cummings Center site, formerly known as "The Shoe"

During 1910, United Shoe Machinery Corporation's factory staff grew from 3,000 to 4,500, and its workweek was cut from 55 to 50 hours. The company reportedly paid its workers the highest average wages in the country, with common stock worth \$70 million by 1911. The company's success came as it converted more and more hand operations to mechanical processes.
